नोट:- बाहरी विद्यार्थियों के प्रवेश केन्द्रीय विद्यालय के पात्र छात्रों/छात्राओं के प्रवेश के बाद केवल बची हुयी सीटों पर केन्द्रीय विद्यालय के प्रवेश दिशानिर्देश 2018-19 के अनुसार होंगे। अनुसूचित जाति/जनजाति/दिव्यांग छात्रों/छात्राओं को नियमानुसार कुल अंकों में 04 % की छूट प्रदान की जाएगी।

(A) KV STUDENTS:-

Admissions in different Streams viz. Science & Commerce of Class XI in KVs for KV students will be based on aggregate marks scored in class X exams as under:-

- (i) **Science Stream (with/without Mathematics):** A Minimum of 60% Marks in aggregate of all subjects.
- (ii) **Commerce Stream:** A Minimum of 55% Marks in aggregate of all subjects.

(B) FRESH ADMISSION TO NON-KV STUDENTS:-

If seats remain vacant in class XI even after admitting the children of KV/neighbouring KVs then the admission to non-KV children for remaining vacancies may be granted on the same criteria, in the sequence of categories of priority.

The Concessions wherever applicable shall be incorporated while preparing the Merit List.

The following concessions will be allowed for admission for Class XI:-

A. The following concession will be granted to students for admission who participated in Games & Sports meet/Scouting & Guiding/NCC/Adventure activities at various levels. The certificate needed for this purpose can be of any of the preceding years.

Maximum concession under Sports/Games/NCC / Scout / Guide/Adventure will not exceed 06% Marks in aggregate. In case of eligibility for more than one concession under different categories as mentioned at (A) and (B) above, only one concession having maximum advantage to the candidate will be allowed (The same benefit may be extended to non-KV Students for fresh admission in KVs).

B. Students belonging to SC/ST/Divyang (PH) would be given up-gradation in aggregate by 04% Marks for the purpose of admission to class XI.

The students of **State Boards/ICSE/NIOS** where marks are awarded **be considered for admission in class XI if vacancies exist.**
